

3. Execute a service agreement with CBES as per proforma enclosed within 15 days from the date of receipt of this Letter of Intent.

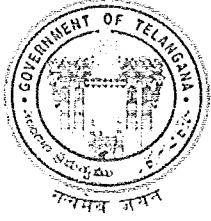
In the event of failure to comply with any of the conditions above mentioned the Letter of Intent shall stand cancelled.

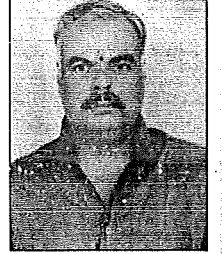
