TGICET-2026 A-Category (Convener Quota) SPOT ADMISSIONS INTO I-SEMESTER MBA / MCA

Interested eligible candidates as per the guidelines issued by Convener TGICET-2026 and who have not taken admission in any Institute can apply and attend Spot Admissions in person at CBIT, Kokapet (V), Gandipet (M), Hyderabad – 500 075. Candidates who have not qualified in TGICET-2026 are also eligible to apply.

The candidates admitted under Spot Admissions are not eligible for any Tuition Fee Reimbursement.

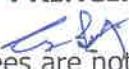

Annual student fee in CBIT

Notice to students seeking admission in the Academic Year 2026-27 into MBA/MCA (post-graduate courses)

All the students who are joining into MBA/MCA post graduate courses through TGICET in Category 'A' and through TGICET/UG Degree marks in Category 'B' in Chaitanya Bharathi Institute of Technology (CBIT) in the Academic Year 2026-27 i.e., in the fee block period of 2025-26 to 2027-28 are hereby informed and put on notice about the following facts :

By virtue of the orders presently in force in W.P. No. 20312 of 2026, the annual student collectable fee for the postgraduate MBA/MCA course in the academic year 2026-2027 is Rs 1,40,000/-, subject to further orders of the Hon'ble High Court. This fee is due and payable prior to commencement of the classwork. The directions in W.P. No. 20312 of 2026 were issued by the Hon'ble High Court in a challenge by CBIT to G.O. Ms. No. 7 dated 04.03.2026 which notified the student fee for the postgraduate MBA/MCA courses at CBIT to be Rs 123,200 /- for the 2025-2028 block period.

It is apposite to note that CBIT collected an annual student fee of Rs 1,40,000/- for the previous academic year also (i.e. 2025-2026) in the fee block period of 2025-26 to 2027-28 on count of the orders in W.P. No. 19573 of 2025, which writ petition is also presently pending before the Hon'ble High Court.

It is a trite and settled proposition that fees will have to increase every block period for the institution to be able to meet its mandatory heads of expenditure. Further, as escalation, inflation, and furtherance together will result in consequent upwards revision in expenditure to be considered while fixing the fee of a subsequent block period.

It is further made clear by way of background that fees of the previous block period had also been revised pursuant to a successful legal challenge by the CBIT

- A. Fees of the 2022-2025 block period have been revised from Rs.90,000/- for MBA & Rs.95,000/- for MCA to Rs.1,10,000/- for MBA & MCA (revision by G.O. Ms. No. 22 dated 25.07.2024).

It is made fully clear that CBIT is seeking enhancement of the quantum of even the presently collectable fee of Rs.1,40,000/- for the 2025-2028 block period let alone the quantum fixed by G.O.Ms.No. 07 dated 04.03.2026, by recourse before the Hon'ble High Court, and other consequential proceeding/s as required, with the entire gamut of grounds available to it in law, and is praying for appropriate enhancement, as even the

presently collectable annual student fee fails to consider and include various mandatory expenditure heads. Therefore, all the students must carefully note that this presently collectable fee is subject to revision, based on the outcome of legal proceedings.

The clear possibility of such enhancement is put to notice of the students, so that they are in transparent possession of full and total information even prior to joining the Institution, and exercise their option to join the Institution only after duly factoring in the possibility of such enhancement to the presently collectable student fee for the MBA/MCA courses. For the purposes of crystal clear clarity, it is reiterated that the quantum of fee fixed by G.O. Ms. No. 07 dated 04.03.2026 is under challenge, and the presently collectable fee as fixed vide directions by the Hon'ble High Court in W.P.No.20312 of 2026, is also under challenge.

This notice will also have to be duly signed by the student and the parent/guardian at the time of admission into the Institute, so there is crystal clear comprehension about possibility of enhancement of the presently collectable annual student fee in the 2025-2028 block period, prior to joining the institution.

TGICET-2026 SPOT ADMISSIONS GUIDELINES TO CANDIDATES

The candidates are hereby informed that the left over vacancies in University / University Constituent / Private Unaided MBA and MCA colleges will be filled by the Institutional spot admissions to be held at the respective colleges. The candidates desirous to seek admission are informed to contact the Principal of the respective institutions.

- The details of colleges and course wise / category wise available vacancies will be placed in the website **<https://tgicet.nic.in>** on 27-08-2026.
- Candidates without original certificates are not permitted for spot admissions.
- Candidate shall present with all original certificates for spot admissions verification. After due verification, the original certificates shall be returned back to the candidate. The candidate has to handover a set of xerox copies of certificates and original transfer certificate (T.C) at the college.
- **Fee reimbursement is not applicable to the candidates admitted under Institutional Spot Admissions.**

I. Eligibility Criteria:

- a. Candidates shall not be allowed for spot admission without original certificates.
- b. The vacancies are to be filled first with those qualified in TGICET-2026 and possessing 50% (49.5% and above can be taken as 50%) marks in aggregate in respect of other than SC/ST/BCs and 45% (44.5% and above can be taken as 45%) marks in aggregate in respect of BC/SC/STs are eligible for spot admission.
- c. If the vacancies are still left, candidates without TGICET-2026 Rank and passed degree or its equivalent examination with the percentage 49.5% and above (OC), 44.5% and above (BC/SC/ST) are to be considered on aggregate percentage of marks in Degree Examination.
- d. Candidates possessing Degree or its equivalent Certificates other than those issued by the University concerned in Telangana are required to get the Equivalency Certificate from the concerned University in the State of Telangana before seeking admission.

- e. Candidates belonging to other state and completely studied there (in Other State) and whose parents belong to other state and residing in other state are not eligible for admission.
