Fee: Rs.1,73,500/- (Annual Tuition fee of Rs.1,65,000/- + Miscellaneous Fee Rs.8,500/-) can be paid either in cash (or) demand draft in favour of "**CBIT FEE COLLECTION AND OTHER RECEIPTS**", payable at Hyderabad. If selected, the candidate must **pay the fee immediately on the spot**. Failure to do so the seat will be allotted to the next eligible candidate.

TGECET-2025 SPOT ADMISSIONS GUIDELINES TO CANDIDATES

SCHEDULE

- Candidate shall present with all original certificates for spot admissions verification. After due verification the original certificates shall be returned back to the candidate. The candidate has to handover a set of Xerox copies of certificates and original transfer certificate (T.C) at the college.
- Tuition Fee reimbursement is not applicable to the candidates admitted Under Institutional Spot Admissions.
- Candidates can verify for the available vacancies duly verifying with institution profile and college wise allotment details.

Eligibility Criteria:

- The vacancies are to be filled first with those qualified in TGECET-2025 and possessing 44.5% and above (for OC) and 39.5% and above for (BC/SC/ST) in the relevant Diploma/B.Sc. Examination.
- If the vacancies are still left, Candidates who have passed Diploma/B.Sc. Examination with 44.5 % and above (OC), 39.5% and above (BC/SC/ST) are to be considered.
- Candidates can note that the conversion of CGPA into percentage as mentioned below.

$$\text{Percentage of marks} = (\text{CGPA} - 0.5) \times 10$$

- Candidates who satisfy the definition of Local/Non-Local shall alone be granted admission.
- Admission to 85% of the seats shall be reserved in each course in the Educational Institutions in the State for the local candidates of O.U. Area as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order, 1974 as subsequently amended and the remaining 15% of the seats shall be un-reserved seats, as follows:

- (i) All the candidates eligible to be declared as local candidates of O.U. Area.
- (ii) Candidates who have resided in the State for a total period of ten years excluding periods of study outside the State or

either of whose parents have resided in the State for a total period of ten years excluding periods of employment outside the State;

(iii) Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporation, Local Bodies, Universities and other similar quasi Public Institution within the State; and

(iv) Candidates who are spouses of those in the employment of the State or Central Government Public Sector Corporations, Local Bodies Universities and educational Institutions recognized by the Government or a University or Other competent authority and similar other quasi-Government institutions within the State.

- Candidate should have obtained a Diploma in Engineering and Technology/ Pharmacy from the State Board of Technical Education and Training (SBTET) Telangana and any other Diploma recognized by SBTET Telangana as equivalent there to for admission into relevant B.E / B.Tech. / B Pharmacy courses.
- Eligibility master in the annexure enclosed shall be followed for candidates qualified in TGE CET.
- Candidates who have passed the Three year B.Sc Degree Examination with Mathematics as one of the subject in the group combination from a recognized University in the State or its equivalent examination are eligible for entry into the relevant courses of Engineering as per G.O. in vogue. All Diploma Holders are to be considered first for available vacancies and thereafter B.Sc passed candidates for left over vacancies in the Institutional Spot admission.
