## **IQAC External Peer Team Report**

As per the request made by the IQAC of the college to the External Peer team members, the peer team visited Chaitanya Bharathi Institute of Technology (Autonomous), Kokapet(V), Gandipet(M), Hyderabad - 500075 on 09-02-2019 and interacted with the Head of the Institution, Directors, IQAC coordinator, Heads of the departments, CoE, AEC – in charge, Administrative Officer, faculty and staff of the college in view of the Extension of Autonomous status. The team reviewed the functioning of the mandatory bodies and the documents concerning the unique initiatives and transparent system developed.

The following documents were verified and noted the regularity and functioning of the mandatory bodies in view of the stipulated UGC guidelines:

- a) The Autonomous Report of the college submitted to UGC for the extension of Autonomy
- b) The timely submitted Annual Quality Assurance Reports (AQAR)
- c) Minutes of the Governing Body, Academic Council, Board of Studies, Finance Committee.
- d) Audited statements of expenditure of the last 5 years.
- e) The minutes of IQAC.

The committee has made the following observations after its interaction and review of documents:

a) The institution has fulfilled all the requirements in the constitution of all the mandatory bodies such as Governing Body, Academic Council, Board of studies, Finance committee and the IQAC. The selection of its members of the bodies and the meetings of these statutory committees are in tune with the UGC guidelines.

- b) The initiatives undertaken are in accordance with the NAAC Peer Team Report / UGC Autonomy Review Team Report / University Autonomy Review Team Report. The college has a clear-cut perspective plan for both long term and short term.
- c) The institution has been initiating new quality academic activities every year. The IQAC has been proactive in strengthening the good practices and ensuring the quality in all activities. The college adopts best practices, teaching methodologies, professional ethics and clearly stated and integrated development policies.
- d) The college has a separate examination section and the unique initiatives of this section include coding system, personal verification of the answer scripts under CC TV surveillance, Revaluation, announcement of results within four weeks after the completion of examination. Advance Supplementary Examinations are in place to safeguard the academic year of the students. Procedure for assessing the quality of question paper is evident.
- e) The Board of Studies of every department has revised syllabus by introducing topics that have relevance. The curriculum emphasis more on the components relating to modern professions in companies and corporates. The vision of the institution is reflected in the redesigned syllabi of various disciplines. The institution has introduced two PG programmes, one in Department of Information Technology and the other in Department of Civil Engineering after becoming autonomous. CBCS was introduced for UG & PG programmes w.e.f. 2016-17 and AICTE Model Curriculum is being followed for UG w.e.f. 2018-19 and for PG w.e.f 2019-20.
- f) Admissions are as per the Telangana State Government norms.
- g) Almanac and Academic Calendar is in place. Classroom teaching is monitored well and all courses are completed in time, Use of ICT tools is in place, Continuous Internal Evaluation is in force.
- h) Good library and Book Bank facilities are available.
- i) Faculty is encouraged for acquiring higher qualifications. Emphasis on participation in seminars / conferences / workshops/ FDPs/ SDPs, etc,

- j) Noteworthy Research projects and Consultancy works are observed.
- k) Good number of Publications in peer-reviewed journals and reputed international conferences is observed
- 1) Good Governance and leadership has led the college to achieve autonomy.
- m) Proactive Management takes keen interest in the growth of the institute.

In addition to all the above stated good practices, there has been full support to co-curricular, literary, cultural, sports and games activities.

The team based on its observation records all the progressive steps under taken by the institution and appeals the UGC to extend Autonomous status to the institution.
