C I R C U L A R

The parents of the present B.E. / B.Tech. 1st and 2nd year students in CBIT who are affected by the enhanced fee were invited on 14th and 15th December 2017 to campus of CBIT and have interacted with the teaching staff of CBIT. Based on the feedback from the teaching staff and the parents the following circular is issued in supersession of all other circulars issued in respect of the enhanced fee for B.E. / B.Tech. 1st and 2nd year students, so that this circular can be used as an authority in times of need ;

The following table shows the admissions made under different categories in the year 2016-17 and in the years 2017-18 :

Out of the above categories the following will be implemented and will hold good till the passing out of the present B.E. / B.Tech. 1st and 2nd year students of CBIT i.e. students admitted in the academic years 2016-17 and 2017-18 ;

- a) With regard to row no.5 i.e., NRI & NRI Sponsored students (Management quota under B-Category) they have paid an annual fee equivalent to \$5000 i.e., around Rs.3,40,000/- to Rs.3,50,000/- and the amount over and above the annual fee of Rs.2,00,000/- is put in a separate account and the same can be utilised to provide scholarships to students from the economically weaker sections falling under rows 1 & 2.
- b) With regard to row no.4 i.e., Management quota under B-Category -all of these students have been put on notice regarding the pendency of the case with regard to fee enhancement on the CBIT website and so referred to in the newspaper advertisement calling for admissions under



B-Category by the Management and further the shortlisted candidates under "B" Category as per merit list displayed on CBIT website were put on notice regarding the pendency of W.P. No. 22564 of 2016 with regard to fee enhancement and they have all given undertaking in respect of the same at the time of admission only. However, the students falling in this category and who have obtained JEE Rank below 20,000 will be eligible for 100% scholarship with regard to the annual enhanced fee of Rs.86,500/-. The remaining students in this row will have to pay the enhanced fee and sufficient time of atleast 6 months will be given to them to pay the same.

- c) With regard to row no.3 i.e., Fully Fee exempted students - SC, ST, Minorities irrespective of rank and BC and EBC below 10000 Rank (under A-Category Convener quota), the enhanced annual fee of Rs.86,500/- will be reimbursed by the respective State / Central Govt. departments and these amounts will not be claimed by CBIT from the students. In case the State/Central Governments do not reimburse the differential enhanced annual fee, CBIT will not collect the same from the students but CBIT will claim the same from the respective State / Central Govt. departments under due process of law.
- d) With regard to rows 1 & 2 i.e., students admitted under A-Category convener quota who are paying the full fee and some with partial fee reimbursement – those students in this category who are economically weak will be provided either full or partial scholarship in respect of the enhanced differential fee based on the report of a sub-committee consisting of Principal, Heads of the Departments and one Member of Board of Management, which will look into such applications of these students / their parents under this category. In respect of students in this category who as a matter of right are not willing to pay the enhanced fee, the college has no quarrel with such students and will not force such students to pay the enhanced fee and it is left to the wisdom of the parents of such students as to whether they do not wish to pay the enhanced fee or they wish to pay the enhanced fee in instalments or they wish to pay the enhanced fee only partially.

It is further informed that the B.E / B.Tech. students admitted in CBIT in the academic years 2016-17 and 2017-18 and their parents can be rest assured that ;

- (i) no student in any of the above categories will be targeted for following this circular and they shall be treated equally and not differentiated by the teaching and non-teaching staff during their course of study in CBIT.
- (ii) the affidavits signed by the students are superseded by the contents of this circular.
- (iii) after graduation the certificates of the students will not be retained for whatever reason in contravention to this circular.
