As per the orders of the Hon'ble High Court of Telangana vide reference 1) cited and the recommendations of the Hon'ble TAFRC reference 2) cited , the tuition fee of CBIT for the block period 2016-17 to 2018-19 is revised from Rs.1,13,500/- to Rs.1,40,000/-

- (i) In the case of students who have already passed out in the year 2020 and 2021 and paid the cumulative tuition fee hike amount in excess of Rs.1,06,000/- [(Rs.1,40,000/- Rs.1,13,500/-) X 4] will be refunded the excess amount paid within a week after receiving the application in the prescribed format giving the details of their bank accounts.
- (ii) In the case of students who were admitted in the year 2018-19 in 1st year and in the year2019-20 in the 2nd year through Lateral Entry of B.E./B.Tech, are hereby directed that they should pay the tuition fee of Rs.1,40,000/- per year instead of Rs.1,62,377/-. If tuition fee paid is in excess of Rs.1,40,000/-, per annum, the same shall be adjusted against their annual tuition fees after receiving the application in the prescribed format from the student within a period of one week.

In order to enable the accounts office of CBIT to arrange for refund of the excess fee paid, the students and their parents are advised to make available to the Accounts department of the college the name of the bank, bank account No. IFSC code, Branch code etc. of the student's/parent's account in case of the passed out students and student's account details for the present students with a copy of the valid ID proof, front page of the pass book/cancelled cheque with name of the account holder immediately in the prescribed format.
