The students of **B.Tech II, III, IV Years, M.Tech II Year, MBA II Year, and MCA II Year** availing scholarships under **SC category** of **Telangana State** are hereby informed that the application for renewal of **Post-Matric Scholarship** through online are started for the **Academic Year 2025–26**.

As per the Government instructions, the **Scholarship option** has been given to the **Institute**, hence **SC category students** are required to bring the following **soft copies (JPG format, file size between 50 KB To 100 KB)** to the Scholarship Section at the earliest, for processing their renewal application:

1. **Present year Bonafide Certificate**
2. **Previous year Marks Memo**
3. **Income Declaration Affidavit on Rs.10/- or Rs.20/- bond paper**

The last date for online application is **20.11.2025**.

After completion of the online renewal process, all applicants must **take a printout** of the application and **submit it along with the Xerox copies of the following certificates** in the **Administrative Office (Scholarship Section)** on or before **30.11.2025** without fail.

Documents to be submitted:

1. Epass online application form.
2. Provisional Allotment Order.
3. **Original Income Affidavit** (signed by the Student & the Parent with date) (Original)
4. Passed/Promoted Marks Memo of Previous year (1st and 2nd semester).
5. Bonafide Certificate (issued by the Exam Branch, CBIT) (Original)
6. Aadhaar Card
7. Student's Bank Account Pass Book
8. Attendance Certificate, certified by the HOD for the academic year 2024–25, is available on the CBIT website (www.cbit.ac.in)
9. If parents are in either private/Govt employment, they should submit salary certificate from their employer.

Submission of Documents:

Students are instructed to send the required **soft copies and documents** to the following email ID: **scholarship@cbit.ac.in**

Note: As per the **Government of Telangana G.O.Ms.No.06 SC Development (EDN.A1) Department**, dated **06.09.2024**, the **SC Scholarship amount** will be **paid directly into the bank accounts** of students. The students in turn are required to pay the same to the college Account, immediately.
