ORDER:

Government has notified the fee for under graduate courses(BE/B.Tech) in Chaitanya Bharathi Institute of Technology(CBIT) as Rs.1,13,500/- and in Mahatma Gandhi Institute of Technology(MGIT) Hyderabad Rs.1,00,000/- for the Block Period, 2016 - 2019 vide reference 3<sup>rd</sup> read above.

2. Aggrieved by the same, the Institutions have filed W.P.No.22564 and 22595 of 2016, the Hon'ble High Court in its common order dated.29.10.2019 in the reference 4<sup>th</sup> read above, have issued the following directions:-

*"directed the 2<sup>nd</sup> respondent-TAFRC to consider the aspects of payment of gratuity and payments made in respect of implementation of 7<sup>th</sup> pay Revision commission, While considering the proposal of the petitioners institution with regard to fee structure, in the next block period and petitioners are also directed to reimburse the excess amount so collected to the students, within a period of eight weeks from the date of receipt of a copy of this order and after excess amounts are paid to the students and material in proof of same is filed, the Registrar (Judicial) shall take action for discharge of Bank Guarantee".*

3. Further, in the reference 5<sup>th</sup> read above, the Hon'ble High Court in its orders dated.29.04.2020 in IA.No.2 of 2019 in W.P.No.22564 of 2016 and I.A.No. 4 of 2019 in W.P.No.22595 of 2016 has issued the following directions:-

*"in view of above facts and circumstances, the review petitions are disposed of modifying the Common order dated. 29.10.2019 directing the respondent to take into account the claims of the petitioners regarding a) amounts expended towards salaries to non-teaching staff, b) expenditure incurred towards implementation of 7<sup>th</sup> Pay Revision commission; and C) expenditure incurred towards increase in gratuity for the block period 2016 -2019 and fix the fee for that block period with in a period of four weeks from the date of receipt of a copy of this order. After fixation of the fee, petitioners have to refund the excess amounts to collected, to the students, forthwith. On proof of the same, the Register (Judicial) shall discharge the bank guarantee furnished by the petitioners forthwith."*

4. The Administrative Officer, Telangana Admission and Fee Regulatory Committee, Hyderabad vide reference 6<sup>th</sup> read above has stated that after thorough discussions on all the issues, Committee opined to enhance the fee Rs.1,40,000/- for Chaitanya Bharathi Institute of Technology and Rs.1,20,000/- for Mahatma Gandhi Institute of Technology for the block period 2016-2019, which would be appropriate and requested for enhancement of fee of Rs.1,40,000/- for CBIT and Rs.1,20,000/- for MGIT for the block period 2016-2019.

5. Government after careful examination of the matter, hereby enhance the fee fixed in the G.O. 3<sup>rd</sup> read above in respect of Chaitanya Bharathi Institute of Technology and Mahatma Gandhi Institute of Technology and issue the following Notification which shall be published in Telangana Gazzete:-

**NOTIFICATION**

In exercise of the powers conferred under sub rule (v) of Rule 4 of the Telangana Admission and Fee Regulatory Committee (For Professional Courses offered in Private Un-Aided Professional Institution) Rules, 2006 issued in G.O.1<sup>st</sup> read above as adapted for the Telangana State vide G.O.2<sup>nd</sup> read above and in pursuance of the recommendations of the Committee(TAFRC) in their meeting held on 07.05.2022 & 12.05.2022, the Governor of Telangana hereby notifies the enhancement of fee fixed in the G.O.1<sup>st</sup> read above, for under graduate courses(BE/B.Tech) for the Block Period, 2016 – 2019 in the following Institutions, subject to condition that the institutions shall not collect excess fee, if they are failed, that said amount shall collect from out of the fee receivable by the institutions for admission of present academic year directly from the Convener, EAMCET Admissions, 2022 :-

1. Chaitanya Bharathi Institute of Technology(CBIT) as Rs.1,40,000/-
2. Mahatma Gandhi Institute of Technology(MGIT) Hyderabad Rs.1,20,000/-
