MCA: All the applied candidates need to attend spot admissions with all the original certificates, Tuition Fee and Miscellaneous Fee of Rs.95,000/- + 7500/- in cash (or) in the form of DD in favor of "CBIT FEE COLLECTION AND OTHER RECEIPTS" payable at Hyderabad.

MBA: All the applied candidates need to attend Spot Admissions with all the original certificates, Tuition Fee and Miscellaneous Fee of Rs.90,000/- + 7500/- in cash (or) in the form of DD in favor of "CBIT FEE COLLECTION AND OTHER RECEIPTS" payable at Hyderabad

Eligibility Criteria:

- 1. Candidates shall not be allowed for spot admission without original certificates.
- 2. The vacancies are to be filled first with those qualified in TSICET-2022 and possessing 50% (49.5% and above can be taken as 50%) marks in aggregate in respect of other than SC/ST/BCs and 45% (44.5% and above can be taken as 45%) marks in aggregate in respect of BC/SC/STs are eligible for spot admission.
- 3. If the vacancies are still left, Candidates without TSICET Rank and passed Degree or its equivalent examination with the percentage 49.5% and above (OC), 44.5% and above (BC/SC/ST) are to be considered on aggregate percentage of marks in Degree Examination.
- 4. Candidates possessing Degree or its equivalent Certificates other than those issued by the University Concerned in Telangana shall be asked to get the equivalency certificate from the concerned University in the State of Telangana before granting admission.
- 5. Similarly, the dropout vacancies (Reported but discontinued) shall be given only for that category.
- 6. Likewise, the not reported cases and cancelled cases should be given only for that category.
- 7. If a particular candidates is not available, they should be converted to another categories as per the Annexure enclosed i.e., finally after exhausting all category candidates the vacancies should be diverted to open category.
- 8. Candidate belonging to other state and completely studied there (Other State) and whose parents belong to other state and residing there only is not eligible for admission. He / She cannot be considered even as NonLocal (NL) candidate to Telangana State for admission and ratification will not be given for such cases if they admit the candidate by violating the guidelines issued.
- 9. Further the candidates admitted during institutional spot admissions are to be informed that their spot admissions are subject to ratification by the Convenor, TSICET-2022 Admissions. In case if spot admission given to a particular candidate is not ratified for certain technical reasons, He / She has to quit the college immediately. This to be made clear to every candidate on the day of conducting the spot admissions in the college.
- 10. Candidates possessing Degree or its equivalent certificates other than those issued by the University Concerned in Telangana shall be asked to get the equivalency certificate from the concerned University in the State of Telangana before granting admission.

Annual student fee in CBIT Notice for students seeking admission during 2022-23

All the students who are joining into MBA/MCA course through TSICET in Category 'A'and through TSICET/Qualifying Examination marks in Category 'B'in Chaitanya Bharathi Institute of Technology (CBIT) for the block period 2022 to 2025 are hereby informed and put on notice about the following facts:

The Tuition Fee as fixed by G.O.Ms. No. 39 dated 18.10.2022 upon the recommendation of the TAFRC for the block period of 2022 to 2025 is Rs.90,000/- per annum for the MBA Course, and Rs.95,000/- per annum for the MCA Course.

The proposal submitted by the Institution to the TAFRC *vide* Letter No. CBIT/247/Admn/2022 dated 07.04.2022 sought for fixation of fee for the 2022 to 2025 block period at Rs.1,26,000/- per annum for the MBA Course, and at Rs.1,26,000/- per annum for the MCA course.

All the students must carefully note that the fee presently collectable being Rs.90,000/- per annum for the MBA Course, and Rs.95,000/- per annum for the MCA Course, fixed *vide* G.O.Ms. No. 39 dated 18.10.2022, is subject to the possibility of enhancement based on the writ petitions to be instituted by CBIT before the Hon'ble High Court and consequent proceedings.

The possibility of such enhancement, as the Institution intends to challenge G.O. Ms. No. 39 dated 18.10.2022and seek appropriate enhancement so that the revised fee includes all the mandatory expenditure heads, is put to clear notice of the students, so that they are in transparent possession of full information even prior to joining the Institution, and exercise their option to join the Institution after duly factoring in the possibility of such enhancement.
