## Annual student fee in CBIT Notice for students seeking admission during 2022-23

All the students who are joining into B.E/B.Tech. course through TSEAMCETin Category 'A'and through JEE Mains /TSEAMCET /Intermediate marks in Category 'B'in Chaitanya Bharathi Institute of Technology (CBIT) for the block period 2022 to 2025 are hereby informed and put on notice about the following facts:

As an interim measure, *vide* order dated 26.08.2022 of the Hon'ble High Court of Telangana in I.A. No.1 of 2022 in W.P. No. 33994 of 2022, CBIT was entitled to collect an amount of Rs.1,73,000/- per student per annumin the 2022 to 2025 block period.

CBIT would have collected the fee of Rs.1,73,000/- per student per annum as a provisional arrangement, while making it fully clear that CBIT shall seek enhancement of this fee by taking recourse to the Hon'ble Courts, with the entire gamut of grounds available to it in law.

Therefore, all the students must carefully note that this fee or the fee presently collectable being Rs.1,40,000/- vide G.O. Ms. No. 37 dated 18.10.2022 is subject to enhancement based on the writ petitions to be instituted by CBIT before the Hon'ble High Court and consequent proceedings.

The figure of Rs.1,73,000/- was recommended by the TAFRC for CBIT in the 2022-2025 block period without there being any government order to that effect until challenge reserved its right to 18.10.2022, and CBIT has Rs.1,73,000/-or any other figure (which figure is now fixed at Rs.1,40,000/- vide G.O. Ms. No. 37 dated 18.10.2022), and pray for appropriate enhancement, as the fee recommended fails to consider and include mandatory expenditure heads (if the mandatory expenditure heads are considered, at the very minimum, the fee ought to have been fixed at not less than Rs.1,91,421/-).

As things stood thus, G.O. Ms. No. 37 dated 18.10.2022 came to be now issued fixing an abysmally low fee at Rs.1,40,000/- in the 2022-2025 block period. CBIT intends to definitively challenge the G.O. Ms. No. 37 dated 18.10.2022 fixing the fee at Rs.1,40,000/- and seek appropriate enhancement so that the revised fee includes all the mandatory expenditure heads. The possibility of such enhancement is put to clear notice of the students, so that they are in transparent possession of full information even prior to joining the Institution, and exercise their option to join the Institution after duly factoring in the possibility of such enhancement.

It is also apposite to mention by way of background information that fees of the 2016-2019 block period were finally revised pursuant to a successful challenge by the CBIT before the Hon'ble High Court, which litigation culminated *vide* Common Order dated 29.04.2020 in Review Petitions in I.A. No.2 of 2019 in W.P. No. 22564 of 2016 and in I.A. No. 4 of 2019 in W.P. No. 22595 of 2016.

The final revised fees pursuant to the directions of the Hon'ble High Court for the 2016-2019 block period was fixed belatedly to be Rs.1,40,000/- per annum as recently as on 14.07.2022 under G.O.Ms. 21 Higher Education (TE) Govt. of Telangana (during the pendency of this litigation, an interim arrangement for enhanced collection was put in place by the Hon'ble High Court).

Consequent to such belated revised fee fixation in respect of the 2016-2019 Block Period, CBIT has immediately represented for revised fee-fixation in respect of the 2019-2022 block period, as it is a trite proposition that fees of the subsequent block period will reflect a necessary enhancement over the previous block period, especially as escalation and furtherance together represent a percentage increase in the subsequent block period over the fees of the previous block period. The revised fixation in respect of the 2019-2022 block period is awaited failing which appropriate proceedings will be instituted by the CBIT forthwith before the Hon'ble High Court seeking enhancement of fees in respect of the 2019-2022 Block Period.

The above background information is being provided as any cascading impact of enhancement in the previous block period (2019-2022) will eventually reflect as a factor in enhancement of fees for the subsequent 2022-2025 block period as well, and so that the students are in transparent possession of full information before exercising their option to join our Institution. This notice is made in two copies, original and duplicate, original to be with CBIT and duplicate to be with the student/ parent/guardian.
