10. minutes of meeting BOS of Chemistry held on 20/07/2016 resolved the following as per Agenda.

Item - I & II
 For Applied Chemistry 1st year between I & 2.
 For ~~some~~ ^{some} of the topics are included in the
 draft and it is also resolved ^{that} applied
 Chemistry ^{Equally} treated as core course. Hence
 3 hours (Instruction period) ^{is suggested} ~~is suggested~~
 instead of 2 periods per week suggested.

It is resolved that Engg. practical (chemistry) Expts for group A & Group B are discussed in length till the ^{draft} syllabus is finalised. The syllabus titles given for Both Theory + practical 1st & 2nd Semesters are appropriate and accepted by the BOS.

ITEM: III & IV

For chemical Engg. it is also resolved that ^(standards org chemistry) as course is considered as core subject, hence it is proposed to ~~go~~ on par with other core subjects i.e. 2 periods is increased to 3 periods per week. i.e. organic chemistry paper.

For 1st ^{sem} it is resolved and recommended that the title ^{is not} ~~is~~ not appropriate. Hence ~~the~~ ^{BOS has suggested} ~~to be~~ for title change (Engg. chemistry to be replaced with Applied Inorganic chemistry) is suggested. For 2nd sem title given is also not appropriate i.e. Applied chemistry which is to be replaced by title organic chemistry similarly Bio-Tech 1st Sem Engg. chemistry is also not appropriate. Hence it is replaced by Gen chemistry by BOS.

The BOS is also suggested that the practical titles given for BioTech & Chem B.Tech chemical Engg. is also not appropriate i.e. Engg. chemical practicals may be replaced as chemistry lab for Bio Tech and Inorganic chemistry (Applied) for B.Tech chemical Engg.

Item V: In the BOS Unanimously resolved that credits given for B.E 1/4 1st & 2nd Sem ~~for~~ for Theory and practicals as approved as it is.









