Summary of the thesis

This thesis addresses an important issue, that is rarely addressed, that is the side effects of various cosmetic products on the facial skin health. With the help of data mining techniques based on rough set theory, the facial skin is categorized into healthy skin and skin having any disorder(s).

The thesis starts with Introduction in the 1st chapter, introducing the reader to the notion of data mining using rough sets, feature extraction, and also cosmetics industry related details. A detailed review of related literature is presented in 2nd chapter.

Chapter 3 presents feature discretization, including discretization using rough sets. Rough set theory-based feature selection/reduction and clustering/classification are presented in chapters 4 and 5. The results generated out of this thesis are presented in chapter 6 and the thesis is summarized and conclusions drawn are presented in chapter 7.

Overall, this is a good research effort.

Questions for the student

The student may be asked to answer the following questions at the time of her viva-voce examination.

1. The first question is about the motivation to use rough set theory-based data mining – would simple machine learning based classification techniques to classify the face into categories such as disorder-free or having a particular disorder have been adequate?
2. Either in chapter 3 or in chapter 4, the student's own contribution is not coming out explicitly. It seems like an extended literature survey. It will be helpful if the student's contribution is made clear with a section title "Proposed method for".
3. The expansion of POSai is not found anywhere. This should be mentioned in full expanded form first time with the abbreviation within brackets.
4. For clustering, K-Means and K-Medoids are both used. The student may comment whether K-Medoids would have suited equally well or K-Means was better for the application she was working on.
5. Is it correct to say that cosmetics are the sole reason for the facial skin disorders? What about the case of getting exposed to sun, dust, smoke and in general pollution due to daily commute to work and study? Can such exposure too cause facial skin disorder? Is this factored into the data mining, whether the users of cosmetics generally stay at home or engage in daily commute?

6. Facial skin disorders like acne etc. may also be caused due to dietary imbalance like excessively oily food. Another factor is stressful living style which can give under-eye black-patches. What normalization was performed by the student so that all other factors are maintained uniform, and only the use of cosmetics would have caused the facial skin disorders?

Examiners Report on thesis entitled "A Rough Set Theory Based Mining Techniques for the Categorization of Facial Skin Disorders" submitted by Ms. Pakalapati M Prasuna, Reg. No. 1003PH0659.

This thesis is presented in 7 chapters while Chapter 6 is devoted to the Results and Chapter 7 is for the conclusion. Chapters 1 and 2 introduce the problem and give an overview of the literature associated to the problem. The problem domain that is face care and the issues with it are introduced in Chapter 2. Other relevant methods and techniques used in this work like feature range selection and clustering methods are also introduced. The core and significant part of the work is seen in Chapter 3-5. These I concentrate upon in the rest of this report.

In this thesis an approach to classify facial disorder categorization is presented that uses rough set theory (RST). It is noted that a clustering approach was used for disorder analysis with 94.5 % accuracy, which is a significant result. Proposed model performs discretization. RST approach is applied with a reduct model to reduce the number of features so as to focus on most relevant features. RST was also useful to improve the cluster quality. The most important results are presented in Chapter 6. Candidate has implemented an approach in ANACONDA SPYDER platform with a data set of 127545 samples. This is a suitably good sized data set.

Table 6.3 shows that only 16 iterations were needed to generate the reducts for the feature set finalization. Classification using SVM and CVBM were shown and compared. Proposed method was shown to be better (Fig. 6.5, 6.6) Precision and recall parameters are shown in Fig. 6.13 and are also consistent with a good approach. F1 scores shown are sufficient to derive the conclusions.

It is also noted that the candidate has presented a method to form clusters (page 95). Later the clusters are converted to classes by the RST method. The crucial contribution is seen in terms of the Algorithm 5.8 where based on a discernibility matrix efficient rule extraction is presented with a decision table.

In Figure 5.2 an image is depicted that shows the domain problem with the picture showing a subject who has the reaction. It appears that this is the same image used by her in the journal publication. It would be more satisfactory if the features and images were corroborated so that we have a visual representation of the features and the disorders. However this is not a major deficiency. It is my advice that the candidate must work further to bring the work to its logical conclusion by applying methods of well know RST expert that is Prof. Pawan J Lingras and his work on "Applying Rough Set Concepts to Clustering", January 2012, with DOI: http://dx.doi.org/10.1007/978-1-4471-2760-4_2. In fact, candidate must pursue publishing in better journals and not just stop with this thesis.

In view of the publications in journals and conferences which are adequate and the good presentation of the thesis I find there are no changes or modifications to be made. Therefore I hereby recommend the award of the degree to the candidate as it suitably reaches the standard for award of the PhD degree.

Main features of the thesis:

- This thesis makes use of Discretization using Rough Set Theory which is described as a method of transforming the values of continuous data attributes into a certain number of intervals.
- Reduct generation using Rough Set Theory is performed. The features considered are reduced by applying the reduct operation that reduces the time complexity of the model.
- Clustering and Classification are performed using Rough Set Theory and deducing the rules for categorization of facial skin disorders with better accuracy.
- The performance is analyzed by comparing with the traditional methods for verifying the accuracy levels and time complexity.
