ITEM 2: To propose and approve the scheme and syllabus for I & II semesters of 4th year B.E. (IT)

- The committee approved the proposed scheme for 4th year B.E. (IT) without any modifications.
- It is recommended to include a course on "Data Analytics using R Programming" as one of the electives under Elective –III of 4th Year BE (IT), II Semester.
- It is recommended to merge UNIT-IV &V and to include 'NOSQL databases' as UNIT-IV in "Big Data Analytics" course.
- It is recommended to specifically mention in the syllabus that "The seminar topic must be chosen from a standard publication (IEEE/ACM/Springer/ Elsevier/John Wiley & Sons Publishing Company etc.) with a prior approval from the designated faculty".
- It is recommended to continue the grading system for B.E. 4th year Main Projects.
- It is recommended to include more text books and online resources in the reference section.

The Board of Studies (IT) approved the scheme and syllabus of 4th year B.E. (IT) with minor modifications.
