### Item 2: To propose and approve the scheme of syllabus for III Semester to VIII semester of B.E. (IT) program under Choice Based Credit System (CBCS)

The proposed scheme of syllabus for III Semester to VIII semester for B.E(IT) program is approved with following suggestions:

- Course on 'Fundamentals of Data Science' is to be included in the IV semester and 'Probability and Random Processes' is to be included under Elective-I in the V Semester.
- Course on "VLSI Technology" is to be included under Elective-IV in the VII Semester.
- Course on "Cloud Computing" is to be included under Elective-VII in the VIII Semester.
- Course title of "Intellectual Property Rights" is to be renamed as "Intellectual Property Rights and Cyber laws".

### Item 3: To approve the syllabus for III and IV semesters of B.E. (IT) program under CBCS.

The proposed syllabus for III Semester and IV semester for B.E (IT) program is approved with following suggestions:

- To write a minimum of 4 course objectives and 6 course outcomes for all theory and lab courses.
- To include around 10 programs/experiments for all laboratory courses.
- The Committee has suggested useful text books and web resources for few courses.
