## ANTI-RAGGING POLICY

CBIT recognizes the definition for ragging as given by the honourable supreme court of India in 1999 in connection with Vishwa Jagrithi case - "Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student. Further, the institute agrees with the expanded definition of UGC (3rd Amendment to its regulations on 29th June, 2016) "Any act of Physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background."

The institute strictly upholds, adheres and implements the regulations of UGC (2009), regulations of AICTE (under sections 23 and section 10 of AICTE Act 1987) in the campus. All the students are well informed of these acts & regulations and their implications. Signed affidavits are collected from all the senior students every year, promising not to indulge in ragging. Further, Anti-ragging Committee (which consists of external members also), Anti-ragging Squad and Anti-ragging Cell are established in the institute to curb the menace of ragging. Details of these are well publicised to facilitate easy access to the students.

Depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, The anti-ragging committee may award one or more of the following punishments, to those who are found guilty.

- Suspension from attending classes and academic privileges.
- Withholding/withdrawing scholarship/fellowship and other benefits such as placements, etc.
- Debarring from appearing in any test/examination or another evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/ expulsion from the hostel.
- Cancellation of admission.
- Rustication from the institution for periods ranging from one to four semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
