Note:-The above fee is subject to any further orders of TAFRC / Government of Telangana / Hon'ble High Court of Telangana.

Annual student fee in CBIT
Notice to students seeking admission in the Academic Year 2025-26 into
B.E./B.Tech. (under-graduate courses)

All the students who are joining into B.E/B.Tech. under graduate courses through TGEAPCET in Category 'A' and through JEE Mains /TGEAPCET /Intermediate marks in Category 'B' in Chaitanya Bharathi Institute of Technology (CBIT) in the Academic Year 2025-26 i.e., in the fee block period of 2025-26 to 2027-28 are hereby informed and put on notice about the following facts:

By virtue of the orders presently in force in W.P. No. 19573 of 2025, the annual student fee collectable for the undergraduate B.E/B.Tech course in the block period of 2025-26 to 2027-28 is Rs.2,23,000/- (presently collectable fee), subject to further orders of the Hon'ble Court. This fee is due and payable prior to commencement of the classwork. The directions in W.P. No. 19573 of 2025 obtained in a challenge by the CBIT to G.O. Ms. No.26 dated 30.06.2025, wherein the Government sought to continue the fee of the previous block period (2022-2025) for the academic year of 2025-2026.

It is a trite and settled proposition that fees will have to increase every block period for the institution to be able to meet its mandatory heads of expenditure. Further, as escalation, inflation, and furtherance together will result in consequent upwards revision in expenditure to be considered while fixing the fee of a subsequent block period.

It is further made clear by way of background that fees of the previous three block periods had accordingly been revised pursuant to a successful legal challenge by the CBIT :

- A. Fees of the 2016-2019 block period have been revised from Rs.1,13,500/- to Rs.1,40,000/- (revision by G.O. Ms. No. 21 dated 14.07.2022)
- B. Fees of the 2019-2022 block period have been revised from Rs.134,000/- to Rs.160,000/- (revision by G.O. Ms. No. 36 dated 06.03.2023) and,
- C. Fees of the 2022-2025 block period have been revised from Rs.1,40,000/- to Rs.165,000/- (revision by G.O. Ms. No. 21 dated 25.07.2024), and this revised fees is subject to the outcome of writ petitions instituted (WP No. 23752 of 2023)/to be amended/to be instituted by CBIT before the Hon'ble High Court, and consequent proceedings.

It is made fully clear that CBIT is seeking enhancement of the quantum of even the presently collectable fee for the 2025-2028 block period let alone the quantum fixed by G.O. Ms. No. 26 dated 30.06.2025 (which is to continue the previous block period fee for the 2025-2026 academic year) by taking recourse to the Hon'ble Court, with the entire gamut of grounds available to it in law, and is praying for appropriate enhancement, as even the collectable annual student fee fails to consider and include various mandatory expenditure heads. Therefore, all the students must carefully note that this presently collectable fee is subject to revision, based on the outcome of legal proceedings.

The clear possibility of such enhancement is put to notice of the students, so that they are in transparent possession of full and total information even prior to joining the Institution, and exercise their option to join the Institution only after duly factoring in the possibility of such enhancement to the presently collectable student fee for the B.E./B.Tech course. For the purposes of crystal clear clarity, it is reiterated that the quantum of fee fixed by G.O. Ms. No. 26 dated 30.06.2025 (which is to continue the previous block period fee for the 2025-2026 academic year) is under challenge, and the presently collectable fee as fixed vide directions by the Hon'ble High Court in W.P. No. 19573 of 2025 is also under challenge.

This notice will also have to be duly signed by the student and the parent/guardian at the time of admission into the Institute, so there is crystal clear comprehension about possibility of enhancement of the presently collectable annual student fee in the 2025-2028 block period, prior to joining the institution.

TGEAPCET(B)-2025 SPOT ADMISSIONS GUIDELINES TO CANDIDATES

The candidates are hereby informed that the leftover vacancies in Universities / University constituent colleges and Private Unaided colleges offering Pharmacy courses, Pharmaceutical Engineering, Bio-Medical and Bio-Technology courses after Final Phase will be filled by the Institutional Spot Admissions to be held at the respective colleges. The candidates desirous of seeking admission are informed to contact the Principal of the respective institutions.

- The details of college-wise, branch-wise and category-wise allotments and vacancies are placed in the website <https://tgeapcetb.nic.in>.
- Candidates without original certificates are not permitted for spot admissions.
- Candidate shall be present in person at college with all original certificates for spot admissions verification. After due verification, the original certificates shall be returned back to the candidate. The candidate has to handover a set of Xerox copies of certificates and Original Transfer Certificate (T.C) at the college.
- **Fee reimbursement is not applicable to the candidates admitted under Institutional Spot Admissions.**

I. Eligibility Criteria:

- a. Candidates shall not be allowed for spot admission without verifying original certificates.
- b. The vacancies are to be filled first with the candidates qualified in TGEAPCET(B) (B)-2025 and passed in qualifying examination i.e, 10+2 examination or its equivalent with group subjects as Botany, Zoology, Physics and Chemistry and possessing 40% (39.5 % & above can be taken as 40%) marks in group subjects

in respect of SC/ST/BC and 45% (44.5% & above can be taken as 45%) for others are eligible for spot admissions.

- c. If the vacancies are still left, candidates without TGEAPCET(B)-2025 Rank and passed in qualifying examination i.e, 10+2 examination or its equivalent with group subjects as Botany, Zoology, Physics and Chemistry and possessing 40% (39.5 % & above can be taken as 40%) marks in group subjects in respect of SC/ST/BC and 45% (44.5% & above can be taken as 45%) for others.
- d. Inter Vocational passed candidates are not eligible for admission into B. Pharmacy and Pharm D courses.
- e. Similarly, the dropout vacancies (Reported but discontinued) shall be given only for that category.
- f. Likewise, the not reported cases and cancelled cases should be given only for that category.
- g. If the particular candidates are not available, they should be converted to another categories as per the Annexure enclosed i.e., finally after exhausting all category candidates the vacancies should be diverted to open competition.
- h. The Principals are hereby informed to adhere with the Government Orders laid down for comprehensive amendments for reservation in admissions in the Educational Institutions as per G.O.Ms.No. 15 Higher Education(T.E) Department dated 27-02-2025 regarding local and Non-local reservation.(The copy is placed in college login.)
- i. Candidate belonging to other state and completely studied there (Other State) and whose parents belong to other state and residing there only are not eligible for admission. He / She cannot be considered even as Non-Local (NL) candidate to Telangana State for admission and ratification will not be given for such cases if they admit the candidate by violating the guidelines issued.
- j. Further the candidates admitted during institutional spot admissions are to be informed that their spot admissions are subject to ratification by the Convenor, TGEAPCET(B)(B)-2025 Admissions. In case if spot admission given to a particular candidate is not ratified by the Convenor, he / she has to quit the college immediately. This has to be made clear to every candidate on the day of conducting the spot admissions in the college.

- k. Candidates possessing intermediate or its equivalent certificates other than those issued by the Board of Intermediate Education, Telangana /A.P shall be asked to get the Equivalency Certificate from Board of Intermediate Education, Telangana before granting admission.
- l. Admission of Bi.P.C students into B.Tech Bio-Technology program without Bridge course in Mathematics is permitted.
- m. The Candidates who have passed Biology, Physics and Chemistry in 10+2 are only eligible for Spot Admissions. Intermediate (Vocational) candidates who had studied Biology, Physics, Chemistry are eligible for PHS: Pharmaceutical Engineering and BTB: Bio-Technology and are not eligible for B. Pharmacy and Pharm D.
