**Circular in respect of payment of Annual Student Fee by the III Semester B.E./B.Tech
Students admitted in the academic year 2025-26 and such Lateral Entry students
admitted in the academic year 2026-27 in the III Semester**

All the III Semester students admitted during the Academic Year 2025–26 in the block period 2025–28, with roll numbers starting with 160125XXXXXX are hereby informed that the Annual Student Fee (tuition fee) has been revised from the previous block period fee of Rs. 1,65,000/- to Rs. 2,23,000/- vide orders of the Hon'ble High Court of Telangana dated 09.07.2025 in W.P. No. 19573 of 2025, while holding that the Convenor, Admissions, TGEAPCET, is directed to update the fee collectable by CBIT to be Rs.2,23,000/- for the Under Graduate B.E./B.Tech. course, per student per annum, for the block period of 2025-26 to 2027-28, in the official website of TGEAPCET and that CBIT is permitted to collect the fees of Rs.2,23,000/- for the Under Graduate B.E./B.Tech. course per student per annum, for the block period of 2025-26 to 2027-28, pending disposal of the writ petition.

Thereafter, the Government of Telangana, Higher Education Department, fixed the annual student fee at Rs. 1,83,000/- for the block period 2025-28 as per G.O.Ms. No. 06 dated 04.03.2026. But the said order of the Hon'ble High Court of Telangana dated 09.07.2025 in WP No. 19573 of 2025 was not set aside and continued to be in force even after 04.03.2026 to till date and the same governs the students admitted in the academic year 2025-26.

Aggrieved by G.O.Ms. No. 06 dated 04.03.2026 fixing the Annual Student Fee at Rs.1,83,000/- per annum for B.E./B.Tech courses in the block period 2025-28, CBIT filed W.P. No. 20256 of 2026 before the Hon'ble High Court of Telangana, and the Hon'ble Court was pleased to pass orders dated 02.07.2026 in the said writ petition, permitting CBIT to collect the fee of Rs.2,23,000/- for B.E./B.Tech courses for the Academic Year 2026–27, pending disposal of the Writ Petition and that the Convenor, TGEAPCET is directed to display in the official website that the Annual Student Fee to be collected for B.E./B.Tech course for the academic year 2026-27 is Rs.2,23,000/- and that the said fees may be increased subject to result of the Writ Petition.

Having regard to the above said orders of the Hon'ble High Court of Telangana, the students admitted in the Academic Year 2025–26 and who are presently in the III Semester and who have only paid an annual fee of Rs.1,65,000/- for the academic year 2025-26, shall have to pay the arrears of Rs.58,000/- for the year 2025-26; and all the B.E./B.Tech students in the III Semester including the Lateral Entry students admitted in the academic year 2026-27, should pay an Annual Student Fee of Rs.2,23,000/- for the academic year 2026-27.
